From a personal point of view, the Cartel Act applies to undertakings under private or public law that are parties to cartels or other agreements affecting competition. In this context, “undertaking” refers to any enterprise engaged in the economic process which offers or acquires goods or services, irrespective of its organisation or legal form (Article 2, paragraph 1 bis of the Cartel Act).
